## ANNUAL PASS AMENITIES

- 50% Off on Practice Range Balls
- 10% Off of Pro Shop Merchandise
  - Discount is off original price, not good with any other specials or offers
  - This discount does not apply to Food, Beverages, or Golf Clubs.
- Advance Tee Time Reservation
  - All pass holders have the right to book tee times up to 7 days in advance.
  - If booking 6 or 7 days in advance, a restriction is imposed of one tee time per pass holder.
  - Pass holders are expected to make cancellations at least 24 hours in advance.

I understand that, as an Annual Pass holder, I receive no special privileges and that I am subject to the same rules and regulations as any member of the public playing at the City of Casa Grande, Dave White Municipal Golf Course. The Annual Pass is Not Transferable, and the pass holder may be required to provide photo ID. Abuse of any and all rules may result in the loss of my pass.

All pass holders must register before playing. If a cart is being used, anyone riding with the Pass Holder (in a cart owned by the city or the Pass Holder) must also have a cart pass or must have paid the daily cart rate. A limit of two (2) carts per tee time will be imposed on all riders.

This pass is valid for daily golf only, and is not valid for tournaments or special events. The course may be closed for play at the discretion of management. The purchaser is not eligible to purchase the annual pass prior to expiration of an active pass. This pass is good for one year starting on the effective date of the pass. Extensions will not be granted.

Partial refunds or credits may only be considered in the event of death within the first 90 days from the original purchase date, according to the guidelines set forth by the City of Casa Grande.

The undersigned pass holder does fully understand that he or she is to abide by all rules and regulations set by the City of Casa Grande. Failure to abide by the rules and regulations will result in loss of golf privileges and fees paid.

\*Note: The City of Casa Grande reserves the right to limit the number of annual passes at the Dave White Municipal Golf Course at any time; however, all current pass holders will have the option to renew their pass within 7 days of expiration at the rates that are in effect at the time of renewal. The city also reserves the right to revoke advance tee time reservation privileges of individuals who do not conform to city policies and procedures.
