- Clean-up must be done within 15 minutes of rental end time.

Palm Island Family Aquatic Park Rules

- All aquatics personnel have complete authority in this facility.
- Children 7 and under and non-skilled swimmers must be accompanied by an adult or per 13 years or older at all times.
- All persons in pool must be in swimsuit. Cut-offs, t-shirts, or leotards are not permitted in the pool.
- No exposed undergarments.
- Improper swimsuits are not permitted in the facility.
- All persons entering the pool area, even non-swimmers, must pay a daily admission fee.
- Water wings or other plastic floatation devices are not permitted in the pool.
- Foul, inappropriate language and loitering is not permitted.
- Gang paraphernalia will not be permitted in the facility, persons displaying gang signs will be asked to leave the facility.
- Firearms, knives, or anything construed as a weapon is prohibited.
- Alcohol or any illegal substances are prohibited. This is a smoke-free facility. Smoking or tobacco is not permitted.
- Outside food and beverages are restricted. Coolers and other food containers are not permitted in the facility.
- Please keep all food, drink, and candy in posted concession areas, must be purchased from concession stand.
- Glass containers are prohibited.
- Day care centers, summer camps and other programs or groups must provide sufficient supervision for their participants. Please consult with a manager to ensure compliance.
- Feet first entries only in all areas, except the diving area.
- Please walk on deck. No running.
- No horseplay, shoulder rides or dunking.
- Please keep all ladders and steps clear. Hanging on ladders, safety lines and railings is not permitted.
- No flips, jack-knifes or cannonballs off the edge of pool.
- Please report any health conditions or disabilities to pool managers before entering.
- Animals are not permitted in the facility unless they are assistance animals.
- Suntan oils are not permitted in the pool.
- The City of Casa Grande is not responsible for lost, stolen or damaged items.
- The City of Casa Grande reserves the right to enforce other rules and regulations that pose a health or safety risk to our guests.

Pool Slide Rules

- Riders must be a minimum of 48" tall.
- Riders must lie on their back at all times.
- No sitting up while riding the slide is permitted.
- Maximum rider weight 300 pounds.
- Do not pull or propel yourself into the ride.
- No combs or foreign objects are allowed in pockets and no jewelry can be worn while riding the slide.
- All riders must ride feet first while lying on their back with arms crossed across their chest.
- Only one rider at a time. Absolutely no trains or chains of riders are permitted.
- No tubes, mats or life jackets are permitted on the waterslide.
- Riders must be in good health. Pregnant women or individuals with heart or back conditions should not use this ride.
- Follow the instructions of the slide attendant.
- No running, standing, kneeling, rotating, tumbling, or stopping in the flume.
- Arms and hands must remain inside the flume.
- No diving from the slides.
- Non-Swimmers not permitted.

City of Casa Grande Community Services Department Code of Conduct

- Failure to obey city laws or ordinances (City Municipal Code) or any action that constitutes a violation of federal, state, or country laws and ordinances.
- Failure to obey posted or published program, park, and facility rules or follow staff member instructions.
- Misuse, destruction, theft, or damage of materials, equipment, furniture or any City property or property of others.
- Vandalism or littering.
- Animals in public facilities with the exception of service animals in accordance with ADA guidelines.
- Possession of weapons, instruments used as weapons, fireworks, or explosives.
- Harassment/Bullying for any reason of participants or staff.
- Inappropriate behavior, language, or clothing that impacts the ability of participants or patrons to be able to enjoy or use a park, program, or facility.
- Smoking of tobacco, E-cigarettes or other substances in areas designated as “No Smoking”.
- Possession, use, or sale of controlled substances.
- Being under the influence of alcohol.
- Inconsiderate or discourteous behavior toward staff or participants.
- Sleeping in a facility or in a park.
- Soliciting, selling, or panhandling.
- Bringing luggage, sleeping bags, or carts into a facility, Department activities using these items are exempt.
- Parking in non-designated areas.
- Unnecessary rough actions against an opposing player, staff, or spectator such as pushing, shoving or physical acts of violence during sporting events or other programs and activities.
- Abusive or threatening language or gestures, whether or not directed at a person.
- Intentionally throwing equipment in anger or disgust.
- Any action that disrupts or obstructs any, program, event or activity.
- Entering any facility, park, or open space when prohibited to do so.
- Any activity, in the judgment of a staff member, which places oneself or others at risk of injury, or infringes upon the rights of other participants or staff.
- Use of any photographic or video device without the expressed written consent of the Department.
- Use of personal electronic equipment, without headphones or refusal to moderate sound levels.
- Inappropriate use of restrooms or other areas (such as bathing or doing laundry)
